The Million Dollar Advocates Forum is pleased to announce that attorney Daniel R Denton of Beaufort SC has been certified as a life member of both the Million Dollar Advocates Forum and the Multi-Million Dollar Advocates Forum.

The Million Dollar Advocates Forum is recognized as one of the most prestigious groups of trial lawyers in the United States. Membership is limited to attorneys who have won million and multi-million dollar verdicts, awards and settlements. The organization was founded in 1993 and there are approximately 3000 members located throughout the country. Fewer than 1 % of U.S. lawyers are members. Forum membership acknowledges excellence in advocacy, and provides members with a national network of experienced colleagues for professional referral and information exchange in major cases. Members of the Million Dollar Advocates Forum must have acted as principal counsel in at least one case in which their client has received a verdict, award or settlement in the amount of one million dollars or more.

Members of the Multi-Million Dollar Advocates Forum must be Life Members of the Million Dollar Advocates Forum and must have acted as principal counsel in at least one case which has resulted in a multi-million dollar verdict, award or settlement.

The cases that qualified Mr. Denton as a life member of both the Million Dollar Advocates Forum and the Multi-Million Dollar Advocates Forum are: 1) \$1.5 Million settlement in a case where a lady slipped and fell on an exterior stairway made of slippery railroad ties with no handrails, causing her to break her leg and later contract RSD, a painful neurological disorder; 2) Jury verdict for \$3.6 Million for a female manager of a store that tripped over an electrical grounding rod protruding above a sidewalk as she was pushing a cart full of boxes to a trash dump behind the store, resulting in herniated cervical discs and a shoulder rotator cuff injury causing chronic neck and arm pain; and 3) \$1 Million settlement for the estate of a young man killed by a drunk driver.

Daniel R Denton is a graduate of University of South Carolina School of Law and has a trial practice with concentration in personal injury and wrongful death, auto accidents, premises liability, slip and falls and on-the-job injuries.
